# Minutes of Monthly Meeting 13 October 2025

**OPENING CEREMONY**: The Sergeant-at-Arms secured the quarters at 1905 hours, posted the Colors and led the detachment in the Pledge of Allegiance; the Chaplain read the opening prayer after which the Sergeant-at-Arms declared the meeting open for official business. Twelve regular members, eleven associate members and one guest were present.

**MEMBERSHIP APPLICATIONS:** Three membership forms are in place. One was present for swearing in. Jacquelyn Wolf who is a friend of Associate Member Robert Vigneault; she is a veteran of the Army and Air Force and works with veterans to get them their GI Bill benefits. Joe Delaney made a motion to accept, second by Dan Bishop and her membership as an Associate Member of the detachment was unanimously approved.

Joe Delaney made a motion to accept the application of Steven Weatherbee who was in the Marine Corps in 1978 and honorably discharged. He was a career planner while he was in the Marine Corps. He will not be available to come to a meeting for a while but the DD214 and application have been submitted. Brian Dupee seconded Joe's motion to approve the application with swearing in at a later time. The motion was unanimously approved to have Steven sworn in at a later time but is officially a member of the detachment in the meantime.

Joe Delaney made a motion to accept the application for Walter Lamon III membership to the detachment. Fran Curnow knows him and would like him to join. He was a Marine and helicopter pilot serving his time in Arizona just after the war. He helped with the golf tournament this year as well. **REPORTS OF OFFICERS** (those not listed had nothing to report or were absent or excused): **Commandant:** Sunday October 19 2025 will be the flag retirement ceremony at 9am. There are

The nylon will be taken to Worcester for recycling by Colleen on her way to Boston for treatment. Junior Vice: Met with the plumber and the backflow valve was ordered. It should be fixed next week along with the sinks pipes that need to be updated.

**Judge Advocate:** The Bylaws were updated in 2020 and need to be updated to reflect the accuracy of attendees to ensure each meeting has a successful quorum for voting. The regular members quorum was twelve members but it should be changed to five regular members to ensure there are enough to vote each meeting. There are 80-90 members on the books but they don't show up to the meetings. Page 10 Section 1 Article 6 needs to be reduced to a smaller quorum. Section 4 is about Associate Members voting rights. This needs language to change giving Associate Members the right to vote on anything other than membership and officers at the local detachment level. They will have a say in any fundraiser or dissemination of funds to the community. The language needed to be updated so there is explicit voting authority allowed to Associate Members at detachment level.

Unanimously accepted \$30,000 for roof repairs including contingency.

Dan Bishop reported the Golf Tournament went well and money needs to be donated so a list was created with some ideas. Please make a list with amounts to bring to vote in December. So far the list is \$500 to the 3 local food pantries, \$500 to Baystate NICU, \$500 to Toys for Tots with Westfield Police Department, Westfield animal shelters \$250 each, \$500 to Boys Scouts for Campership, \$250 to Cub Scouts, \$300 to Boys and Girls Club, \$1700 to Amelia Park for the boards previously discussed in September. Amelia Park sponsorship is from September to September so this will have to wait until next year. The price includes our skate party. We can continue to discuss year round giving to help the community so please make lists and amounts to bring up at future meetings. We have signs that state we give money to other local charities so we need to start donating the money brought in by our fundraising efforts.
